## **Common Catastrophic Injuries**



**Spinal Cord Injuries** 

Traumatic Brain Injury (TBI)

Loss of Limbs / Major Amputations

Severe Burns

Multi-Trauma

These types of injuries can be life-threatening and often result in permanent disability or significant lifestyle changes.





## **Claim Scenario**

Date of Accident: November 2023

Age: 42 years old

**Occupation:** Police Officer

**Description of Injury:** 42-year-old male who was responding to a call when he was involved in a motor vehicle accident with an 18-wheeler.

**Diagnosis:** Mild traumatic brain injury, C-6 fracture, C5-C7 spinal cord lesion, tetraplegia (paralysis affecting the arms, hands, trunk, legs, and pelvic organs)

## **Timely Investigation**

- Cause of accident
- Initial injury information

### **Identify Stakeholders and Key Parties** • Contact the insured and your carrier • Are there any third parties involved?

### Secure Field Case Management

• Catastrophic nurse preferred




